

Q1. WHERE IS OAKWOOD GARDENS PHASE 1?

A. Oakwood Gardens is situated in Lakowe, by Lakowe Golf Course, off Lekki- Epe expressway.

Q2. WHO ARE THE OWNERS/ DEVELOPER OF OAKWOOD GARDENS PHASE 1?

A. PWAN HOMES LTD, a Leading Real Estate Company and Folkland Property Development Company (FPDC), a leading player in the Construction sector of the economy with offices in Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES OAKWOOD GARDENS PHASE 1 HAS ON THE LAND?

A. Deed of Assignment with Land Owners, Governor Consent and Registered Survey plan approved by Lagos State Government.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?
