FREQUENTLY ASKED QUESTIONS / TERMS & CONDITIONS

Q1. WHERE IS PARADISE GARDENS?

A. Paradise Gardens is situated in Free Trade Zone Area, off Lekki- Epe expressway.

Q2. WHO ARE THE OWNERS/ DEVELOPER OF PARADISE GARDENS?

A. PWAN HOMES LTD, a Leading Real Estate Company and Folkland Property Development Company (FPDC), a leading player in the Construction sector of the economy with offices in Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES PARADISE GARDENS HAS ON THE LAND?

A. Deed of Assignment with Land Owners, Registered Survey plan approved by Lagos State Government and Gazette.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A. The land is free from every known government acquisition or interest and adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE? (Outright and Instalment Payment)

A. (a) Payment of #350,000 Initial payment and #262,500 monthly instalments for 12 months for 600sqm (#3,500,000) & #175,000 Initial payment and #131,250 monthly instalments for 12 months for 300sqm. (#1,750,000)

(b) Outright payment is N3,150,000 only per plot for 600sqm & N1,575,000 only per plot for 300sqm

(c) Commercial plots Attract additional 10% of land cost

(d) Corner piece plots Attract additional 10% of land cost

(e) Change/Correction of Name(s) attract N10,000 charges (Subject to review)

(f) Transfer of Ownership attract 10% of land cost

(g) N.B :- Non-payment of the monthly instalments as at when due shall be treated as a fundamental breach of the contract which could result in termination or revocation of the contract/OR attract a default charge of 10% of the monthly instalment payment.

A. 600sqm And 300sqm

Q7. IS THE ROAD TO THE ESTATE MOTORABLE?

A. Yes the road to the estate is motor able.

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND?

(a) Deed of Assignment: N200,000 only per plot for 600sqm & N100,000 only per plot for 300sqm (subject to review)

(b) Survey plan Fee: N380,000 only per plot (subject to review) Survey plan with Company's name attract double charges

Q9. WHEN DO I MAKE THE OTHER PAYMENTS?
