FREQUENTLY ASKED QUESTIONS / TERMS & CONDITIONS

Q1. WHERE IS SAFARI PARKS?

A. SAFARI PARKS is situated in Okun-Imosan Village, Free Trade Zone Area, off Lekki- Epe expressway close to Lakapine Tropicana.

Q2. WHO ARE THE OWNERS/ DEVELOPER OF SAFARI PARKS?

A. PWAN HOMES LTD, a Leading Real Estate Company with office in Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES SAFARI PARKS HAS ON THE LAND?

A. Deed of Assignment with Land Owners and Registered Survey plan approved by Lagos State Government.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A. The land is free from every known government acquisition or interest and adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?
