FREQUENTLY ASKED QUESTIONS / TERMS AND CONDITIONS OF PURCHASE

- Q1. WHERE IS OLIVE PARK ESTATE PHASE 1?
- A. OLIVE PARK ESTATE PHASE 1 is situated in Abule PAN, Ayeteju, Ibeju Lekki. It's about Thirty (30) minutes drive from Ajah bus stop.
- Q2. WHO ARE THE OWNERS/ DEVELOPER OF OLIVE PARK ESTATE PHASE 1?
- A. PWAN HOMES LTD, a Leading Real Estate Company and Folkland Property Development Company (FPDC), a leading player in the Construction sector of the economy with offices in Lekki, Lagos State.
- Q3. WHAT TYPE OF TITLE DOES OLIVE PARK ESTATE PHASE 1 HAVE ON THE LAND?
- A. Deed of Agreement with Land Owners, Lagos State Government Approved Survey Plan. And Excision
- Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?
- A. The land is free from every known government acquisition or interest and adverse claims.
- Q5. WHAT IS THE PAYMENT STRUCTURE?
 - (a) 3 Months instalments Payment is (#2,500,000)
 - (b) Outright payment is N2,250,000 only per plot
 - (c) Commercial plots Attract additional 10% of land cost
 - (d) Corner piece plots Attract additional 10% of land cost
 - (e) Change/Correction of Name(s) attract N10,000 charges (Subject to review)
 - (f) Transfer of Ownership attract 10% of land cost

Q7. IS THE ROAD TO THE ESTATE MOTORABLE?

A.Yes the road to the estate is motor able.

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND?

(a) Deed of Assignment: N200,000 only per plot. (Subject to review)

(b) Registered Survey Fee: N 380,000 only per. (subject to review) Survey plan with Company's name attract double charges

(c) Development Fee: Will be communicated later

(d) Corner Plot demarcation: N70,000 only per plot (Subject to review)

Q9. WHEN DO I MAKE THE OTHER PAYMENTS?

A. (i) Survey Plan and Deed of Assignment payment can be made before or after the Physical Allocation, (ii) Development Levy will be determined later.
(iii) Corner Plot Demarcation is N30,000 per plot payable after payment for land and before Physical Allocation of plot.

Q10. WHAT DO I GET AFTER THE INITIAL DEPOSIT?

A. Starters pack comprising a letter of acknowledgement of subscription, receipts of payment.

Q11. WHAT DO I GET AFTER COMPLETING PAYMENT FOR THE LAND?

A. (a) Completion Payment Receipt, Contract of Sales & Payment Notification Letter (a) Deed of Assignment & Survey Plan after Physical Allocation is done.

Q12. CAN I START CONSTRUCTION OR BUILDING ON THE LAND NOW?
